## Advice from the Government of Kiribati of a New Vessel to be Included on the Register of Authorised Inspection Vessels

Dear All,

In accordance with paragraph 17 of CMM 2006-08 *Western and Central Pacific Fisheries Commission Boarding and Inspection Procedures*, please find attached advice from the Government of Kiribati for addition of **RKS Teanoai** on the Commission HSBI Register of Authorized Inspection Vessels.

WCPFC3 agreed that boarding and inspection operations pursuant to the procedures would be authorised to begin 60 days after the circulation to CCMs by the Executive Director of the Register of Authorised Inspection Vessels. Accordingly, the effective date for the newly authorised Inspection Vessel to commence boarding and inspection under procedures of CMM 2006-08 is **18 May 2014.**
